After three years an additional booking fee of \$250 will apply. **Stallion Service fee cannot be sold or transferred to anyone else.** The only exception is if a mare is sold in foal to one of

our stallions, then the contract will go to the new owners of the mare.

**COLLECTION FEE:** A \$250 collection fee is charged for each weekday (MWF) collection if the collection is done at Marabet Farm. Weekend collections are \$350 if possible. If the collection has to be done at a reproduction center or vet clinic, due to the stallions show schedule, they will bill you directly on your credit card.

**SHIPPING FEE:** Shipping is through FedEx. Please feel free to use your own FedEx account if you have one. All collection and shipping fees can be paid by credit card or through our PayPal account.

**SHIPPING CONTAINERS:** Charge for the disposable Cardboard/Styrofoam container is \$40 each. If you prefer us to use an Equitainer a \$350 deposit for the Equitainer is required. **Equitainer RETURN** is required within 48 hrs after insemination to avoid late fees. Please DO NOT return the units via US Mail. FedEx and UPS are fine. We recommend that you insure Equitainers for \$350.00 in case of loss of contents or entire unit. Equitainers not returned to Marabet Farm LLC will incur a \$350.00 replacement charge.

### RESERVATIONS FOR SEMEN:

---

Collections are done on weekdays (MWF) and all shipments will be FedEx Priority Overnight if possible in your zip code. Friday shipments can only be done if your zip code accepts Saturday delivery or you can pick-up shipment at a FedEx center.

**Same day shipments** are possible using FedEx SameDay Service MWF but additional shipping fees will apply. Collections on weekends if possible are \$350.

24 hours' notice or more for semen collections is requested, but all requests for semen must be made by 11:00 am EST on the day of the collection request for a guaranteed shipment. Last minute requests will be fulfilled whenever possible but an additional fee of \$50 will apply.

When possible, please notify Marabet Farm of your mare's reproductive status so that a shipment date may be anticipated then follow up with the final order. Requests will be honored in order of receipt.

**ALL COLLECTION AND SHIPPING FEES MUST BE PAID BEFORE SHIPMENT IS SENT.**

### DISCOUNTS

---

- 1) Performance Mare Discount: \$50 off. Please enclose copy of show records. To be decided by stallion owner.
- 2) Elite & Premium Mare Discount: \$100 off (Must provide proof from registry)
- 3) Multiple Mare Discount: \$100 off each mare for two, \$150 off each for three and four and over \$200 off for each mare
- 4) Repeat Breeding Discount: \$100 off

### BREEDING CERTIFICATE:

---

**\*\* Breeding certificates will be available at the end of the breeding season. \*\***

**PLEASE NOTIFY** Marabet Farm of the result of your mare's pregnancy check. We recommend the first check no later than 16 days after ovulation. This will allow enough time for your breeding manager to prepare your mare for another cycle's breeding if she's not in foal. Please feel free to consult with Marabet Farm regarding any reproductive management issues your mare may have.

---

### RETURN OF SERVICE:

---

The mare owner shall have the right of return to the Stallion's service in the next season only under the following circumstances:

If the mare does not settle during the present breeding season, she is eligible for return of service to the stallion if the mare owner submits a veterinarian's certificate to that effect.

If the mare is examined in foal but becomes barren during gestation, she is eligible for return if Marabet Farm receives a veterinary certificate of barrenness within thirty (30) days of the examination.

If the Mare subsequently produces a live foal that is unable to stand alone and nurse, and subsequently dies, or if the foal dies due to illness or accident within 1 month of birth, a veterinary certificate must be provided within ten (10) days of death. Foalings must be attended.

If the Mare becomes unfit for breeding or otherwise unbreedable, purchaser may substitute another mare of equal quality. Purchaser must request this change in writing.

All rights of return to the stallion are subject to prepayment of costs set forth in the "FEES" section above.

---

### CONDITIONS

---

Marabet Farm assumes responsibility to deliver live semen in viable condition at the time of delivery to the supplied shipping address. The semen must be administered by a licensed Veterinarian or by a breeding technician on the same day it was received, or Marabet Farm will be considered to have fulfilled their contractual obligation and any other guarantees will not apply. Marabet Farm is not responsible for any veterinary bills associated with breeding your mare. Please choose your Veterinarian carefully, as not all are familiar with and skilled at equine reproduction.

Mare Owner understands that the Mare must be examined by a licensed veterinarian 60 days after the last day bred and Marabet Farm notified of her pregnancy status at that time.

### NO REFUND OF FEES – NON-TRANSFERRABLE

---

Once purchased there is no refund of stallion service fees. If the stallion should die or become unfit for service prior to serving the mare in the present breeding season the Mare owner shall have the right to one dose of frozen semen of that stallion or may substitute any other Marabet Farm stallion for fresh semen. If the fee for another Marabet Farm stallion is higher the difference will be paid by the Mare owner. Stallion contracts are non-transferrable to other people and may not be sold. Contracts will be honored if a mare is sold in foal to one of our stallions.

### LIABILITY

---

The Mare Owner shall assume all responsibility for the condition of the Mare and shall bear all risk of loss or damage to the Mare, whether by death, disease, injury, infection or otherwise, and by any cause whatsoever, and therefore agrees to hold Marabet Farm LLC and/or any person associated with Marabet Farm LLC harmless for any and all damages associated therein.

This pre-signed contract will serve as your copy and is valid as soon as you send, fax or email your signed contract and your payment is cleared. Once your payment is cleared this contract is assumed, enforceable and considered signed regardless of actual signature.
